

## HTC RELEASES UNAUDITED RESULTS FOR 4Q 2011

**Taoyuan, Taiwan – January 6, 2012** – HTC Corporation (TWSE: 2498), a global leader in mobile innovation and design, today announces unaudited consolidated results for 4Q 2011. For the fourth quarter of 2011, total revenues reached NT\$101,419 million, a decrease of 2.49% year-on-year. Unaudited operating income was NT\$12,982 million, net income before tax was NT\$13,243 million, net income after tax was NT\$11,017 million, and unaudited earnings per share after tax were NT\$13.13 based on 839,117 thousand weighted average number of shares.
