

HTC RELEASES UNAUDITED RESULTS FOR 3Q 2011

Taoyuan, Taiwan – October 6, 2011 – HTC Corporation (TWSE: 2498), a global leader in smartphone innovation and design, today announces unaudited consolidated results for 3Q 2011. For the third quarter of 2011, total revenues reached NT\$135,821 million with 79.07% year-on-year growth. Unaudited operating income was NT\$20,190 million, net income before tax was NT\$21,291 million, net income after tax was NT\$18,638 million, and unaudited earnings per share after tax were NT\$22.03 based on 846,016 thousand weighted average number of shares.
